Payments must be made weekly unless otherwise agreed. Loyalty scheme payments must be made in full, in advance of the first walk. Another amount per walk must be agreed by both parties if it differs from above.

2a. The client shall pay an out of area charge of £2 extra per walk, if they live 5 miles or more away from the Walker's address.

3. In temperatures above 20°C, the Walker reserves the right to shorten the walk, if deemed necessary for the dog's well-being, and will spend the rest of the time with the dog in the Client's house and garden. In temperatures above 25°C, the Walker reserves the right to do house visits instead of walking if deemed necessary for the dog's well-being. The Client in both circumstances will be informed.

- 4. The Walker shall notify The Client of any occurrence regarding to the dog(s) which may be important to the care and well-being of the dog(s).
- 5. The Client shall notify The Walker of any occurrence regarding the dog(s) which may affect the service being provided by The Walker, including but not restricted to illness and injury.
- 6. The Walker shall perform the agreed-on services in an attentive, reliable and caring way and The Client does hereby agree to provide all the necessary information to assist The Walker in this performance.
- 7. The Walker shall supply and always be equipped with waste bags and will promptly remove all dog faeces from all public grounds.
- 8. The Owner will provide suitable collars and leads that are approved by The Walker as well as a jacket and muzzle if required. A valid and up-to-date engraved ID tag must be worn by the dog at all times when out in public, to comply with the 'Control of Dogs Order 1992'.
- 9. The Walker will carry spare leads and collars and is entitled to use them at any point deemed necessary.
- 10. If the dog(s) has unsupervised access to the outdoors at home The Walker shall not be liable for any mishap of any nature regarding the dog(s).
- 11. The Walker shall not be obligated to perform any other duties except walking the dog(s) and/or feeding/providing a toilet break/clearing up destruction or faeces/urine to ensure comfort of the pet is upheld, if this has been agreed with the owner.
- 12. The Client does  $\Box$  does not  $\Box$  (select as appropriate) allow The Walker to exercise the dog(s) off lead. The Walker does not accept liability for any mishap occurring whilst the dog(s) is off lead, including loss, injury or theft.
- 13. The Walker is an independent contractor with respect to this Dog Walking Contract and is not an employee of The Client and The Client will not provide any fringe benefits, such as health insurance and paid vacation for the benefit of The Walker.
- 14. The Walker hereby warrants to keep safe and confidential all The Client's keys, remote control entry devices, access codes and any other personal information of The Client and to return all items to The Owner at the end of the contract period or immediately upon request by The Client.
- 15. The Walker hereby accepts no liability for any breach of security or loss of or damage to The Client's property if any other person is given access to the property during the term of this Dog Walking Contract.
- 16. The Walker is released from all liability that is related to any transporting the dog(s) to and from any veterinary facility for any necessary medical treatment and incurred medical expenses. The Walker is

released from all liability of injury to the dog(s) caused by other dog(s) or animal(s) that are not under the control of The Walker.

- 17. The Client will keep The Walker informed about any changes to contact details.
- 18. The Walker will keep The Client informed about any changes to contact details.
- 19. If The Client wishes to cancel one or more scheduled walks then they shall give 24hrs notice, or be held liable for the full walking fee (except for exceptional circumstances).
- 20. If The Walker is unable to carry out a scheduled walk, then they are entitled to allow another suitably experienced person to carry out the walk for them. The Walker reserves the right to cancel the walk without prior notice. No fee will be incurred for this.
